

- (a) The course work shall be of 16 credits, which may consist of the following:

- (ii) Two Courses of 4 credits each, of Post Graduate level.
- (iii) One Course of 2 credits on and publication misconduct.
- (iv) One Course of 2 credits his/her area of research.
- (v) In addition to above, specially designed courses of 2 or more credits of at least one semester duration offered by the Department / Faculty / Centre concerned in the relevant broad area of research.
