"University Examinations in Programmes regulated by Statutory Bodies"

Clause No.	Existing Ordinance	Amended
6.2	(v) Any student who does not clear the BDS examination in all the subjects within a period of 9 years, including one year compulsory Rotatory paid internship from the date of admission shall be discharged from the course.	<p>Replace sub-clause (v) by the following:</p> <p>(v) Any student who does not clear the first year BDS University examination in all subjects within three years from the date of admission, shall be discharged from the programme and his/her admission shall be cancelled.</p> <p>(vi) The maximum permissible time limit for completion of BDS Programme shall be eight years, inclusive of the year of admission.</p> <p>(vi-a) Any student who does not clear the BDS Programme in all the subjects within a period of 9 years, including one year compulsory rotatory paid internship from date of admission shall be discharged from the programme.</p> <p>This provision shall be applicable only to those students admitted into the BDS Programme with effect from 27.04.2015. However, old cases will be dealt with under clauses 6.2 (v) and 6.2 (vi).</p>
