## Ordinance 31 (XXXI) [academic]

"Fellowships, Scholarships and Gold Medals for Students"

Para No.	Existing	Amended
		Add the following new para:
5		5. Leave Entitlement for UGC Non-NET Fellows.  Leave for a maximum period of 30 days in a year, in addition to public holidays, may be taken by a Ph.D. student who has been awarded UGC Non-NET Fellowship, with the approval of the Ph.D.  Supervisor. However, he/she will not be entitled to any other vacations, for example, summer, winter etc.  Women awardees will be eligible for "maternity leave" at full rates of the fellowship for 135 days as per Government of India rules once during the tenure of her award.  The awardee may in special cases be allowed leave without fellowship/associateship and contingency by the University Grants Commission for a period not exceeding three months during the tenure of award, on the recommendation of the Ph.D. Supervisor/Head of the Department concerned. The period of leave without fellowship/associateship will be counted towards the tenure.
