ADDENDUM

In continuation to this Office Notification of even number dated 11.04.2022 & addendum dated 10.05.2022, it is for the information to all the concerned that the Vice-Chancellor, JMI in terms of Clause 11 (3) of JMI Act, 1988 and on behalf of the Majlis-i-Talimi (Academic Council) and the Majlis-i-Muntazimah (Executive Council), has approved the following addendum to the Ph.D. Ordinance-9 (IX) Degree of Doctor of Philosophy (Ph.D.) [Academic]:

[After renaming clause 1 {Eligibility Criterion for Full-Time Ph.D. Admission) as clause 1(i), the proposed clause will be incoroporated as clause 1(ii) and will be added after clause 1(i)]

Proposed Addition/Amendment

1. Supplication Facility for permanent JMI university teachers for pursuing Ph.D. - A permanent faculty member (Assistant Professor, Associate Professor and Professor) who holds a Master Degree in the relevant subject and has been working or appointed in a relevant subject for the 3 years in Jamia Millia Islamia is eligible. The relevance of the Ph.D. topic is to be decided by the BoS/CoS at the time of considering the application for supplication. He/she may apply through DRC/CRC for permission to submit the thesis for the award of the Ph.D. degree on a specific topic and the BoS/CoS may accord such permission after considering the opinion of the DRC/CRC. A teacher so permitted to submit the thesis may or may not be assigned any supervision, depending upon the recommendation of the BoS/CoS and shall be eligible to submit his/her thesis not before 03 years after approval or his/her application by the BoS/CoS subject to the fulfillment of rest of the conditions applicable to General Ph.D. candidates like course work, submission of progress report to the BoS/CoS, Pre-Ph.D. submission seminar, publication of one paper in journal and presentation of two papers in conferences and seminar and other conditions applicable from time to time.

5 (g) If an academic staff/research personnel whose superannuation term-end is due in less than three years, the BoS/CoS may only appoint him/her as Co-supervisor of a Ph.D. scholar.

5 (g) Teachers of the university who have less than two years to retire may not be appointed Supervisors, but can be appointed as a Co-Supervisor.

Existing provision Proposed Addition/Amendment 6 (b) If a supervisor retires **6 (b)** A retired teacher may continue to supervise the research after supervising a scholar scholar(s) assigned under his/her supervision after his/her for three or more years, the retirement till the submission of the thesis or upto three years DRC/CRC may recommend whichever is less or unless he/she declines to remain the supervisor or leaves Delhi. The student will, however, be under him/her as the co-supervisor after obtaining his/ her the Head of Department/Director of the Centre for consent. administrative supervision including scholarship, fellowship, attendance, leave etc.

The action of the Vice-Chancellor will be reported to the forthcoming meetings of the Academic Council and Executive Council.
