The Registrar appreciated valuable contributions rendered by the Hon'ble outgoing Amir-i-Jamia (Chancellor) Lt. Gen. (Retd.) M.A. Zaki to the august body during his tenure as Chancellor.

Reso. No. 1 ELECTION OF AMIR-E-JAMIA (CHANCELLOR) JAMIA MILLIA ISLAMIA.

On completion of five year term by Lt. Gen. (Retd.) M.A. Zaki as Chancellor, Jamia Millia Islamia, the Shaikhul Jamia, Jamia Millia Islamia proposed the name of Dr Najma Heptulla as Amir-e-Jamia (Chancellor), Jamia Millia Islamia. Since there was no other proposal, the Anjuman (Court) unanimously elected **Dr (Mrs) Najma A. Heptulla, Hon'ble Governor of Manipur** as **Amir-e-Jamia (Chancellor)** of Jamia Millia Islamia for a period of five years in terms of Statute 1 of Jamia Millia Islamia Act, 1988 with acclamation.

Reso. NO.2 CO-OPTION OF SIX MEMBERS OF THE ANJUMAN (COURT) OF JAMIA MILLIA ISLAMIA IN TERMS OF STATUTE 11 OF JMI ACT 1988 WHICH HAS FALLEN VACANT ON THE EXPIRY OF THREE YEARS TERM.


The Anjuman (Court) was informed that six persons representing learned profession and special interests including representatives of industry, commerce, trade unions, banking and agriculture are co-opted by the Anjuman (Court) under the Statute 11 of the Jamia Act 1988. The term of the previous six co-opted

members has expired. Hon'ble members of the Court proposed names of persons of different fields in place of the outgoing members as new members of Anjuman (Court).

After detailed deliberations, the Hon'ble members of Anjuman (Court) co-opted the following persons to the Anjuman for next three years:
