



About Jamia Millia Islamia

Jamia Millia Islamia, an institution originally established at Aligarh in United Provinces, India in 1920 became a Central University by an Act of the Indian Parliament in 1988. In Urdu language, Jamia means 'University', and Millia means 'National'.

Jamia Millia Islamia came into existence through the tireless efforts of its founders, such as Shaikhul Hind Maulana Mahmud Hasan, Maulana Muhammad Ali Jauhar, Hakim Ajmal Khan, Dr. Mukhtar Ahmad Ansari, Jenab Abdul Majeed Khwaja and Dr. Zakir Husain. The story of its growth from a small institution in the preindependence India to a Central University located in New Delhi offering integrated education from nursery to research in specialized areas is a saga of dedication, conviction and vision of a people who worked against all odds and saw it growing step by step. They "built up the Jamia Millia stone by stone and sacrifice by sacrifice," said Sarojini Naidu, the nightingale of India. At present, Jamia Millia Islamia is an ensemble of a multi layered education system nurturing over 18000+ students, more than 800 full time faculty teachers, 9 faculties and 38 departments offering more than 200 courses. In 2015, NAAC accredited the University with 'A' grade etching its names among the esteemed Universities of the country. In 2020, Jamia Millia Islamia was ranked 1st among all central universities in the country in rankings released by Ministry of Education of India. 
Department of Social Work

The Department of Social Work at Jamia Millia Islamia was established in 1967 with an aim to impart Social Work education at the under graduate level. Subsequently, in 1976, the post graduate programme in Social Work was introduced. In the year 1991 it was accorded the status of Department of Special Assistance (DSA) by the University Grants Commission (UGC), which was then followed by two more phases. The DSA and ASSISH have together strengthened the department both in terms of academic quality and infrastructure. After several phases of special assistance, in 2010, the UGC recognized the Department as a Centre of Advanced Study in Social Work. The Department of Social Work has been in the forefront of academic and field innovations in the country and has been consistently upgrading its curriculum to make it more responsive to the social challenges in India.

The Department of Social Work is well known for its teaching and instructional programmes. It maintains a progressive and people centred emancipatory focus in its pedagogy, research and field action. Presently, the Department offers the following instructional programmes: Masters in Social Work, Masters in Human Resource Management, Advance Diploma in Public Health and integrated M.Phil./Ph.D. Programmes.

The Department also prides itself in predominantly adopting the pedagogy of participatory learning, closely mentored internships in different settings of social work practice, experimental learning opportunities in primary as well as advanced skills of social work and regular interface with practising professionals. It boasts of first rate highly qualified and field grounded faculty. The Department also boasts of excellent infrastructure in terms of smart classrooms, a modern conference room, well stocked seminar library, a computer and data processing laboratory and an advanced behavioural and personality enrichment laboratory. The zest for evolving and at the same time maintaining quality keeps the department on its toes through each day and each moment.

Pedagogy



Course Structure

The course structure of M.A. in Social Work is a four semesters, post — graduate program with a broad and generic base. The Program is open to graduates of all academic disciplines and is designated to meet the growing human resource requirements in the field of Welfare and Development.

The Program lays a foundation in Social and Behavioral Science and Social Work methods in the first two semesters. Skill labs are also aimed at understanding self, gaining communication and research skills, and participatory techniques. Moreover, in the second semester, the Department of Social Work organizes an educational camp for ten days for the students.

The advanced knowledge and exposure to Welfare or Development perspective (determined by the specialization that the student has opted for) is provided in the final year. Students who opt for Social Welfare as their stream in the third and fourth semester are provided with specialized inputs for working at the micro and meso level. Skill labs are also aimed at strengthening their competencies for direct intervention with the client system (therapeutic interventions and relevant tools). Field work opportunities to students are provided in organizations where opportunities for intensive individual and group level interventions are available (students are placed in mental health settings, statutory or non — statutory institutions involved in child protection or domestic violence, de — addiction facilities, services for differently abled, institutions offering counseling and care and support services, etc.)

The students opting for Social Development are trained to analyze macro social realities and understand its implications for human deprivation. They are assisted in developing a critical awareness of the social dimensions of economy and policy. The students acquire the ability for making interventions at the macro and meso level through policy research, advocacy, training and documentation. Skill labs are also aimed at strengthening their knowledge of tools of social and policy assessment, designing livelihood plans, skills of marketing and accounting, etc. Field work opportunities to students are provided in organizations having significant focus on policy analysis, advocacy, training, research, documentation, and networking (organizations working on issues of education, health, environment, gender, homelessness, informal economy, children, marginalized groups, governance, etc.).




Orientation:

The Department of Social Work, Jamia Millia Islamia organized a week long orientation program for the enrolled students of Semester-1, batch 2020-2022. The program served as brainstorming trailer to the holistic learning and practice for the upcoming years in the social work practice. The objective of the program was to acquaint the students with an understanding of fundamental values, tools, methods and principles that lay as the backbone of the profession. During the transaction of this program the students gain an insight of a professional social worker's life through the diverse enriching field experiences shared by the expert resource persons from there dignified fields. The program entail an exposure to the diverse areas of social work profession involving education, poverty, marginalized communities, social movements, social action, livelihood, homelessness, children, health, challenges in pandemic, issues of the elderly, LGBTQ and Gender. Despite the limitations of the pandemic the online program was a massive success in imbibing the students with the right impetus for growth and learning as future social work professionals.









Skill Lab:

Skills Lab sessions are an integral part of the department's goals. They are facilitated either by faculty members or people from outside resources. With the help of these sessions, students are trained and develop many skills throughout and at the same time their personality development takes place. During the first semester, the focus is on communication, questioning and personal development. During the second semester, students receive research training and prepare a research proposal as part of their assessment report. In the third semester, students receive training in computer applications as well as project-based training. Skills workshop topics include, but are not limited to, APA tools, group therapy interventions, research tool building, data analysis, life skills programming, skill retention in casework, defense, family therapy, budgeting, assessment, etc. Faculty instructors support the application of these skills in fieldwork.

Field Work:

Field work training plays an important role in the career development of social work students. It offers students the opportunity to apply theoretical knowledge, skills and values in organizational and community contexts. More importantly, fieldwork simultaneously creates a holistic understanding of social issues and their causal factors and offers the opportunity to reflect on intervention strategies. Because fieldwork is a one-year journey and involves rigorous training, students are placed in various government / non-governmental organizations. Each student is provided with a supervisor who guides him/her in achieving the basic objectives to understand the nature of the work. For each semester, the objectives are carefully designed to maximize the focus on the relationship between theory and practice. From understanding community dynamics to developing intervention strategies and applying the different tools and techniques, each student learns what it takes for a social worker to practice.










Rural Camp:

Rural immersions is one of the most significant scholastic components of the course. It exposes the students to the rural realities and is pivotal for training the students as professionals that are well acquainted to work in diverse settings. The department has successfully completed this component risk free in the online mode. The online rural camp had it's own perks and pleasures, it was an amalgamation of workshops, movie screenings, participatory presentations, interactive activities and feedback sessions. The students gained an intrinsic understanding of application of various tools, techniques like PLA, PRA and methods of social work deployed in rural settings. The department also invited several Alumni of the department to enlighten the students with their memories, challenges and learnings from the camp. Students got acquainted with a variety of rural institutions and their functioning. The innovation with technology allowed the students understand and develop social skills and competence to work in rural settings.









Value Additions

Individual Conference

Individual Conferences (IC), a critical tool of supervision, is arranged to facilitate interaction and feedback between the supervisor and supervisee in a systematic and confidential setting, ICs are held every week during the assigned time. It provides a platform to discuss the issues and concerns arising out of field work. The supervisor facilitates the process to help students relate theory with practice, and monitors their progress in terms of accomplishment of field work objectives. It provides the student an opportunity to reflect on their strengths and areas of improvement.

Group Conference

Group Conference is a vital part of the field work training. It enables the students to develop some of the basic skills to become an effective social work professional. Group Conferences are held twice in the whole course duration; one during semester II, and the other during semester III. It provides the students the opportunity to get exposure to a wide range of areas. Each student is supposed to assume the role of a Chairperson, Presenter, and Rapporteur at least once in each Group Conference. It provides the students with an opportunity to experience the process of presentation of a formal academic and practice oriented paper, to chair and moderate a formal discussion in a systematic, precise and formal manner, and to develop an understanding of various settings and opportunities relevant to the field of Social Work.

Computer Classes

The Department of Social Work facilitates technical knowledge of computer programs like Microsoft Excel and Statistical Package for the Social Sciences (SPSS) to the students through the medium of computer classes. This aids in enhancing their technical competency and IT skills. Owing to the circumstances caused by COVID, the Department has made arrangements to impart the said technical knowledge through the platform of online skill lab classes and breakthrough sessions. This has enabled the students to equip themselves with the necessary technical competencies of quantitative analysis required in the professional context, aided them extensively in their dissertation process and has directly contributed to their process of learning as well.

Workshops

Beti Bachao Orientation Training Program by NIPCCD, WCD

National Institute of Public Cooperation and Child Development organized an Orientation Training on Beti Bachao Beti Padhao for faculty and Scholars of Social Work Department from 24-25 Feb 2021. Smt. Vandana Sharma, Asst. Director NIPCCD, reflected on the Genesis Beti Bachao Beti Padho Scheme & Advocacy for Social and Behaviour Change. Prof. Archana Dassi, took a session on Gender Sensitization — Understanding the impact of inequality on Child Sex Ratio. Ms. Vimla Makhloja, State Project Coordinator, Mahila Shatki Kendra (MSK) Uttrakhand, emphasized on Improving CSR & Education of Girl Child and shared best practices from the field. Ms. Himali Joshi, Specialist Training SRCW shared her experiences from the field in Gujrat.


StandUp Training program by Breakthrough

StandUp is an awareness and training program against street harassment, developed by Breakthrough and L'Oréal Paris in partnership with the expert NGO Hollaback!. The program offers a proven methodology – "The 5D"– to help both men and women to safely intervene if they witness or experience street harassment. It trained the students on how to safely defend themselves and to help victims of street harassment by using the 5Ds: Direct, Distract, Delegate, Document, Delay, beginning with Distraction, the simple act of interrupting an incident by asking the time or pretending to be lost. By opening the public eye to the scale of harassment women in particular, experience, the training aimed to simultaneously discourage harassers, support victims and encourage bystanders to intervene in a safe manner.

Project Management Workshop

A Project Management workshop was organized by the department of social work to aquaint the students with the nitigrities and nuances of project management. The workshop emphasized on the value of project management and discussed the essentials for a good project proposal. The facilitator shared proposals from the field to draw an understanding of the various key elements comprising a good project proposal like thorough research, mapping out contingency, expanding possibilities and concerned policy frameworks are major areas of consideration. The facilitator through his hands on experience from the field expanded the perspectives on social work profession. The profession demands one's commitment towards constant learning and urging project responsibility, expanding beyond the traditional ways.




