**Decision on the mercy appeal dated Nil submitted by Mrs. Shahzad Anjum Laeeq wife of Shri Laeeq Ahmad, Farrash, regarding restoration of services of her husband.**

The Majlis (EC) noted that the Executive Council in its meeting held on 01.04.2011 (vide its Resolution No. EC-2011(IV) Res-05) had resolved to remove Mr. Laeeq Ahmad, Farrash, from the services of the Jamia Millia Islamia. Mr. Laeeq Ahmad was informed about the EC's Resolution terminating his services with immediate effect (vide Office Order No. F. No. 4-47/RO/Estt./2011 dated 13/04/2011).



Mrs. Shahzad Anjum Laeeq, w/o Shri Laeeq ahmad, had vide a representation (dated nil) appealed for sympathetically consideration in view of the poor financial condition of the family.

The Majlis (EC) considered her appeal sympathetically, and resolved to reduce the penalty of Shri Laeeq Ahmad from that of "Removal" to "**Compulsory Retirement**".


The Majlis (EC) in its meeting held on 01.04.2011 (vide EC-2011(IV) Res.No. 6) had *proposed* the removal of Dr. Deepak kem, Associate Professor, Jamia Millia Islamia, in terms of Statute 37(4) of the Jamia Millia Islamia Act, 1988. Dr. Deepak Kem was informed of the said Resolution of the Majlis-i-Muntazimah (Executive Council) (vide an Office Order dated 11.4.2011) seeking his response to the propose penalty.

Vide a letter dated 03.05.2011, Dr. Deepak Kem responded to the said proposed penalty.

The Majlis (EC) duly considered the letter of Dr. Deepak Kem (dated 3.5.2011) along with the entire records of the disciplinary proceedings. The members of the Majlis (EC) were the opinion that intellectual plagiarism is a serious misconduct in an institution of higher education, and no laxity can be granted in such cases. The "unqualified apology" offered by Dr. Deepak Kem "for inadvertent and unintentional lapse" was not acceptable. The Majlis (EC) also noted that the charge of plagiarism was proved as per the Inquiry Report of Shri S.M. Chopra, former Additional District and Session Judge, Delhi.

Resultantly, the proposed penalty of "Removal from the Services" against Dr. Kem was confirmed by the Majlis (EC) with immediate effect.

**To report the actions taken by the University consequent upon the declaration of Jamia Millia Islamia as Muslim Minority Institute by the National Commission for Minority Educational Institutions.**

The Majlis (EC) noted and endorsed the action taken by the University consequent upon the declaration of Jamia Millia Islamia as a Minority Institution by the National Commission for Minority Educational Institutions as per details shown at **Annexure-IV**.

The Vice-Chancellor also apprised the members about the three petitions challenging the order of the National Commission for Minority Educational Institutions filed by by Shri Vijay Kumar (WPC No. 1970/2011), Shri Awanish Kumar (WPC No. 2934/2011) and Centre for Public Interest Litigation (WPC No. 3320/2011) managed by Mr. Prashant Bhushan, Advocate. The petitions were heard in the High Court of Delhi on 18.05.2011. The Hon'ble Court did not grant a stay on the implementation of the order of the Commission and the notification of the Ordinance 6(Academic)(VI) of the university and asked the petitioners and respondents including Jamia Millia Islamia to file their propositions and positions on affidavit before the next hearing scheduled on 14 July 2011. The case have historical implications on the future of Jamia and the eminent senior Advocates of the Supreme Court namely Mr. T.R. Andhyarujina and Mr. Rajeev Dhawan whose services were hired, informed that the University should prepare itself for a long haul as the case would certainly go to the Supreme Court for a final resolution.

The Majlis (EC) authorized the Vice-Chancellor to proceed in the matter and to sanction expenditure to any extent required on legal and other related matters for the protection of Jamia's interests.



The Foundation decided to make Jamia Millia Islamia the Nodal Agency to create an archival library on Haj affairs in South Asia. An agreement to this effect has been finalized and is awaiting the Saudi Cabinet approval.

He also informed about the two separate Memorandum of Understandings (MoUs) signed by Jamia, one with Imam Mohammad bin Saud University the other with King Saud University on exchange of scholars and faculty in the field of Sciences and Humanities. Five Postgraduate/Doctoral Scholarships were approved for the Jamia students by the King Saud University along with the establishment of a Chair in the name of King Abdullah-bin-Abdul Aziz. He also informed that a request for another Chair in the name of Prince Salman-bin-Abdul Aziz was made and it was promised to be considered favorably by the Rector of King Saud University.

The meeting concluded at 4.40 p.m. with a vote of thanks to the Chair.
