

EC-2013 (III): Reso.-05**Appeal submitted by Mr. Ashok Kumar Sharma, Lower Division Clerk (L.D.C), against the proposed penalty imposed on him of "removal of his services" from Jamia Millia Islamia.**

It was noted that the *Majlis-i-Muntazimah* (Executive Council) held on 30.01.2013 vide its Reso. No. 12, after careful perusal of service records of Mr. Ashok Sharma, Lower Division Clerk (LDC) along with Inquiry Report, has unanimously resolved to agree with the proposed penalty of "Removal from the services of Jamia Millia Islamia" by the *Shaikhul Jamia* (Vice-Chancellor). This was communicated to Mr. Ashok Sharma, giving him opportunity to submit any representation against the proposed penalty.

Representation of Mr. Ashok Sharma dated 16.03.2013 was carefully considered by the Majlis (EC). The Majlis (EC) took serious note of the allegation leveled by Mr. Ashok Sharma with regard to discrimination against him as he belongs to Minority Community. Keeping in view the fact that Mr. Ashok Sharma has consistently adverse records, the Majlis (EC) decided that no laxity should be granted in such cases. Resultantly, the proposed penalty of "Removal from the services of Jamia Millia Islamia" against Mr. Ashok Kumar Sharma was confirmed by the Majlis (EC) with immediate effect.

Action: OSD**EC-2013 (III): Reso.-08****Consideration on the reply submitted by Prof. Anwar Alam against the proposed penalty of "removal of his services" from Jamia Millia Islamia.**

The representation of Prof. Anwar Alam (under suspension) [dated 12.04.2013] in response to the 'proposed' punishment of "Removal from the services of Jamia Millia Islamia" following the mandate of the Executive Council (Resolution No. EC-2013(II):Reso. 9) of its meeting held on 25.02.2013 was considered.

The *Majlis* (EC), carefully perused all the records and arrived at conclusion that the Charged Officer held a re-examination on 13.12.2011 {just two days after the actual conduct of the Examination}, without changing the Question Paper, in which he himself was the Paper Setter, Superintendent of Examination also the Evaluator and no one was on Invigilation Duty. Secondly, all the Faculty Members were unanimous that the case of Ms. Versha Tomar (the student) was not discussed, nor was it on the Agenda, in the Faculty Committee Meeting (as wrongly claimed by the Charged Officer). Since, there is enough evidence relating to misconduct committed by Prof. Anwar Alam, it would not be necessary to refer the matter to a handwriting expert.

The Majlis (EC) was of the strong view that misconduct viz-a-viz manipulation in examinations is a serious issue, and cannot be condoned in premier institution of higher learning. Any indulgence, if granted, shall impact the standards of the Jamia Millia Islamia and be deleterious to its academic environment. The highly irresponsible misconducts of Prof. Anwar Alam are perceived as extremely grave. The Majlis (EC) examined all the issues raised by Prof. Anwar Alam in his representation dated 12.04.2013 with due care and attention while reiterating its earlier stand [Resolution No. EC-2013-(II): Reso. – 09 of Meeting held on 25.02.2013] resolved the 'Removal' of Prof. Anwar Alam from the services of the University *with immediate effect*.



The Majlis (EC) noted that Prof. M. G. Husain was suspended w.e.f. 05.09.2011 in contemplation of disciplinary proceedings. Mr. M.S. Sabharwal (Ex-District and Sessions Judge, Delhi), was appointed as Inquiry Officer and Prof. M. Obaid Siddiqui, Director, AJK MCRC, was appointed as Presenting Officer. (A copy of the Inquiry Report submitted by the Inquiry Officer, was circulated to all the members of the Majlis (EC) along with the Agenda for their perusal and record).

The Majlis (EC) considered in detail the Inquiry Report submitted by the Inquiry Officer and advised that a copy of the Report may be sent to Prof. M. G. Husain, giving him an opportunity to submit representation, if any, against the findings of the Inquiry.

It was also resolved that this case may be brought before the Majlis (EC) along with the representation, if any, received from Prof. M. G. Husain, for consideration and taking appropriate decision by the Majlis (EC).

Further, the Majlis (EC) approved the transfer of Dr. Tanweer Fazal, Associate Professor from Centre for Jawaharlal Nehru Studies to Nelson Mandela Centre for Peace & Conflict Resolution.

EC-2013 (III): Reso.-12**Decision on the appeal submitted by Mr. Satpal, Safai Karamchari against the proposed penalty imposed on him of "Removal from the services of Jamia Millia Islamia".**

It was noted that the *Majlis-i-Muntazimah* (Executive Council) held on 25.02.2013 vide its Reso. No. 07, after carefully perusing the service records of Mr. Satpal, Safai Karamchari along with current Inquiry Report, unanimously resolved to agree with the proposed penalty of "Removal from the services of Jamia Millia Islamia" by the *Shaikhul Jamia* (Vice-Chancellor). This was communicated to Mr. Satpal giving him an opportunity to submit any representation against the proposed penalty.

The representation of Mr. Satpal dated 05.04.2013 was carefully considered by the Majlis (EC). The Majlis (EC) also noted that Mr. Satpal has consistent adverse records.

Therefore, the Majlis (EC) decided that no laxity should be granted in such cases. Resultantly, the proposed penalty of "Removal from the services of Jamia Millia Islamia" against Mr. Satpal was confirmed by the Majlis (EC) with immediate effect.

Proposal for delegation of powers for acceptance of resignation tendered by the university employees

The Majlis (EC) noted that in accordance with Statute 14 (2) (ii) the powers of appointment such Professors, Readers, Lecturers and other academic staff etc. rest with the Executive Council. As a general principle, the appointing Authority is resignation accepting Authority. Since tendering of resignation is a routine practice in service career and sometimes employees request for immediate relieving, it is practically not possible to keep pending their requests till decision of Executive Council.

The Majlis (EC) while considering the above stated facts, resolved to delegate the powers for acceptance of resignation to the Vice Chancellor as per Statute 41 of JMI Act 1988.

EC-2013 (III): Reso.-14

Proposal for transfer of the post of Professor of Education along with incumbent to the Department of Educational Studies, Faculty of Education, JMI.

The Majlis (EC) noted that the Department of Educational Studies is a Postgraduate Department which runs Ph. D. M.Ed., M.Ed. (Elementary), M.A. (Educational, Planning and Administration) Programmes. Research Methodology is one common paper which is taught as an integral component of the syllabi for all courses. Being the postgraduate and research focused Department it requires a senior faculty who has expertise in the field of research methodology as well as having practical experience of doing research of high standard. The Department of Educational Studies have no senior faculty member having specialization in the area of Philosophy of Education or Sociology of Education.



The Majlis (EC) while considering the above facts, resolved to transfer Prof. Aejaz Masih, who has rich experience in the above field from Department of Teacher Training & Non-formal Education (IASE) along with the post occupied by him in IASE to Department of Educational Studies.

Besides above, the Majlis (EC) resolved that the post vacated by Professor Mohammed Miyan in Department of Educational Studies shall be transferred to Department of Teacher Training & Non-formal Education (IASE) in lieu.


