

To Report the Correction in Office Order

- 2.4 The *Majlis-i-Muntazimah* (Executive Council) vide Reso. No. EC-2012(VII):05 of its meeting held on 17.07.2012 proposed penalty of removal of **Mr. Arif Ali Khan**, Workshop Instructor (under suspension) from the services of Jamia Millia Islamia. Subsequently, the EC vide Reso. Consideration on the request of DMRC for requirement of additional land from Jamia Millia Islamia for construction of Jamia Millia Islamia station and portal pier PP-47 of viaduct on Janakpuri West-Botanical Garden Corridor.

The Majlis (EC) noted the details of land provided to the DMRC for construction of the Jamia Millia Islamia station and portal pier PP-47 of viaduct on Janakpuri West-Botanical Garden Corridor and the compensation money received against the transfer of land for the said purpose as given below:



1. The DMRC had requested for 2253.94 sq.m. land on permanent basis and 1823.93 sq.m. land on temporary basis. The Executive Council of Jamia Millia Islamia has already approved the transfer of University land on permanent & temporary basis as required by DMRC for construction of Metro Line & Station as shown in the drawing submitted by the DMRC.
2. The Compensation Money amounting to Rs.1,04,81,434/- and Rs.12,72,266/- respectively for permanent and temporary land transfer have been received.
3. The lands required by the DMRC as approved by the Executive Council have been handed over to the authorized representative of DMRC as per the details and drawings approved by the University.

The Majlis (EC), while noting the above facts, considered and approved the request of additional land required by the DMRC vide letter No. DMRC/PM-7C/12 dated 14.01.2013 on temporary/permanent basis on the same terms and conditions of the agreement for construction of Metro Station and portal pier PP-47 of viaduct on Janakpuri West-Botanical Garden corridor (Line-8) of Delhi-MRTS:

Note: While 85.24 sq.m. of land is near Engineering Faculty at the corner of the University boundary for construction of portal pier PP-47, 1179.95 sq.m. of land on "temporary basis" is after Noam Chomsky building in Khasra No. 68 (part). It is under encroachment which will be removed as & when the police is made available. The third portion of the land is on permanent basis measuring 127.34 sq.m. for Jamia Nagar Station near University Qabristan along erstwhile old building of Ansari Health Centre.

The Majlis (EC) noted that a complaint was received against Prof. Halima Sadia Rizvi, Head, d/o Economics regarding intellectual plagiarism on her part. A preliminary inquiry to this effect was conducted by the Honorary Vigilance Officer, JMI. On the basis of the Report of Preliminary Inquiry, the Vice-Chancellor has ordered to institute a full-fledged Departmental Inquiry proceeding against Prof. Halima Sadia Rizvi. Findings of the full-fledged Inquiry shall be placed before the *Majlis-i-Muntazimah* (EC) on completion of the inquiry.

Consideration of the reply received from Prof. Anwar Alam, Centre for West Asian Studies, JMI.


The Majlis (EC) considered in details the Inquiry Report submitted by Mr. B.L. Garg, Additional District & Sessions Judge (Retd.) against the misconduct(s) committed by Prof. Anwar Alam, the evidence on record, and the representation of the Charged Officer.



The Majlis (EC) noted as under:

- (a) As per the Inquiry Report, the charges leveled against Prof. Anwar Alam stand conclusively proved;
- (b) There is clinching evidence on record that the Charged Officer misconducted himself viz-a-viz the charges framed against him;
- (c) All the relevant witnesses unequivocally stated that Ms. Versha Tomar (the concerned student) did not appear in the examination on 10.12.2011, tampering was done increasing the number of candidates from 7 to 8 (seven to eight). Ms. Rizvi (PW-5) had stated that Ms. Tomar was found writing in the room of the Charged Officer on 13.12.2011 and that he (the Charged Officer) had asked her about the cutting which was done by him in the students' sheet and as to what should be done in the said regard.
- (d) Before the Vigilance Officer, the Charged Officer has himself admitted (in writing) his misdemeanor;
- (e) The Charged Officer has also stated before the Inquiry Officer that no one was the Invigilator for the subsequent examination of Ms. Versha Tomar;
- (f) It is also corroborated by evidence in the inquiry that the case of Ms. Versha Tomar was not discussed in the meeting of the Committee of Studies. The Faculty members present have testified convincingly to that effect.
- (g) The Majlis (EC) did not find any merit in the representation of the Charged Officer. There (was/and is) no ground to allege that the Inquiring Authority was biased. The case of misconducts against the charged officer has been conclusively proved. The Charged Officer was given the opportunity to defend himself.

The totality of facts and circumstances pointedly lead towards the guilt of the Charged Officer. Resultantly, the Majlis (EC) proposed his Removal from the services of Jamia Millia Islamia. However, in terms of Statute 37 (4) of the JMI Act, 1988, the Charged Officer is given an opportunity to showing cause against the action proposed to be taken for due consideration of the competent authority.

The Majlis (EC), while approving the above, noted the justification that one post of Associate Professor and one post of Assistant Professor were advertised on 10.02.2012. Last date for receiving applications was 10.01.2013. Selection Committee held on 11.02.2013 recommended Ms. Saima Saeed, working as Assistant Professor at the Centre for the post of Associate Professor. The Committee also found two very good candidates for the position of Assistant Professor (one against the advertised post and one against the post to be vacated as a result of Ms. Saima Saeed's selection). In the past, we have faced such situations where it was found that good candidates are lost to other Universities due to time taken in advertising and requirements of recruitment process. The Centre has also applied to UGC for DRS induction, which requires the Centre to have a minimum of faculty members.


